**NOW THIS DEED WITNESSETH AS FOLLOWS**

1. In order to effectuate the said desire of creating and establishing a charitable trust the settler do hereby appoint the above trustees and delivered to and made over to the trustees, the trust property with intent to part with all their right, title and interest, claim therein and vest the same in the trustees to have and to hold the same and the investment for the time being represent the same and all other properties that may from time to time being represent the trust estate together with all additions and accretions thereto and all accumulated income thereof

2. The Trust shall be called "**GURUKRUPA FOUNDATION**" having its Registered Office at Plot no A/37, Bhagabatipur, Kantabada, Ps Chandaka, Bhubaneswar, Dist:-Khurda, Odisha -752054 and/or such other place or places as the trustees may decide from time to time. The effective date for Change of Registered Office as mentioned above is from 28<sup>th</sup> February 2023.

3. **JURISDICTION:** The jurisdiction of the Trust shall be throughout India.

4. The object for which the trust fund is established are relief to the poor, advancement of education, health, sanitation, medical relief and the advancement of any other object of general public utility and under area the following not involving at the carrying on any activity for profit without distinction of Caste, Colour, Creed and community and includes the following objects:

- To establish and run of educational institutions including Schools, +2 Science, commerce and arts colleges and Degree & higher courses.

- To establish institutes for offering professional undergraduate and post-graduate courses in Business Management, Marketing, Public Relations and Publicity, Journalism and Mass Communication, Travel and Tourism Management, Hotel Management, Interior Decoration, Accountancy, Secretarial Services, Book-keeping, Store keeping, Costing and Auditing, Archaeology, Library Science, Production Control, Both online & offline Training and examinations and allied activities, etc.
- To establish technical institute for conducting courses for various industrial trades such as Fitter, Wireman, Welder, Electrician, Mechanic, Computer Data Processing, Electronics, Television, Radio, and other household gadgets, maintenance and repairing, Draughtsman, Surveyor, Typewriting, Stenography, Medical Technician and Nursing, Paramedical Course, Photography, Printing and allied courses etc.
- To encourage and expand the scientific and technological ideas in the existing educational institutions of the State of Orissa for elevating the quality of education.
- To print, publish and circulate books, pamphlets, periodicals etc for developing scientific and technological outlook among the general public with a special thrust on technically qualified personnel.

- To employ, seek and utilize the services (either free or on payment) of the experts for the execution of the objectives of the trust.
- To Create and manage assets, properties, endowments, funds etc. in furtherance of the objectives of the trust.
- To establish laboratories, workshops, educational aids and technical facilities for practical training and demonstration; for the students of various courses offered by the Trust.
- To offer assistance for industrial undertakings in selecting proper personnel, in maintenance and repairs of their equipment and assist in production managements and erection, layouts.
- To obtain excellence in academics, accreditation of different programs, deemed university status and ISO 9002 certification etc. from appropriate authority as shall be required from time to time.

- To form/register separate charitable trust/sister group with existing members and outside members, if required, for smooth functioning of the work of Trust.
- To purchase or take on lease, plots of land or buildings, or to receive by way of gift, grants, donation, and /or benefaction of land and/or building or to construct, maintain, renovate, repair, take over, buildings, infrastructure, or property of any nature or any interest herein and any rights easements, privileges which the trust may think necessary or convenient with reference to any of its objectives. And from time to time such buildings, infrastructure, or property may be permitted to be used by the

- To draw, make, accept, endorse, discount, execute & issue cheque, promissory notes and other negotiable or transferable instruments.
- To undertake all activities and to do all such things as are incidental, instrumental and conducive for the attainment of the aims and objects of the trust enumerated above.
- To undertake such other activities not specifically mentioned here above in the interest of achievements of the aims and objects of the trust as decided by the Executive Committee from time to time.

5. **TRUST PROPERTY**

The settler had vested finally and irrevocably a sum of ₹.10,000/- (Rupees Ten Thousand) only from his own funds.

The aforesaid sum of Rs10,000/- (Rupees Ten Thousand) only will be the initial fund of the Trust. Any further sums received in the form of money or money's worth by way of donations, gifts, and grants or acquired by any other mode by the Trust will be the property of the Trust.

6. **BOARD OF TRUSTEES**

The Administration, Management and control of the Trust and its properties shall vest in the hands of a committee to be called the Board of Trustees, consisting of following persons for the time being.

(a) The first Board of Trustees of Trust who have accepted to be the Board Members shall be as below:

1. Sri, Prafulla Kumar Swain, **Chairman-cum-Managing Trustee**
2. Sri Baishnab Charan Patra, Trustee
3. Sri Bijoy Kumar Rout, Trustee

(b) The Trustees shall hold office during their life unless any of them desires to be discharged of his duties or becomes mentally or physically incapable of working or is declared insolvent or is convicted of a criminal offence. If required or deem fit, the Board of Trustees may induct new Trustee/s for life time or for limited period with unanimous consent and decision to fulfill the objects of the Trust.

(c) In the event of a vacancy arising in the Board of Trustees for whatever reasons, the remaining Trustees shall co-opt another major male or female person to fill up the vacancy.

- (d) Whenever necessary any Trustees may opt to retire or otherwise will have power to nominate his/her successor to be noted in the resolution of the Board of Trustees and the successor so chosen will have all rights and liability like any other Trustees. Such nomination may change from time to time. If any Trustee shall die, the surviving Trustees shall be entitled to appoint one of his/ her successor in the place of the Trustees dying. The Trustee so included will have all rights and liabilities like any other Trustees.
- (e) The number of Trustees shall at no time be less than two and more than seven.
- (f) The Trustees shall work for the promotion of the objects of the Trust and in the interest of the Trust and shall be entitled monthly remuneration in lieu of the services rendered and re-imbusement of expenses for imparting education as well as in discharging the required duties for the institution and the Trust the fixation of the remuneration is to be determined by the Trust Board in terms of resolution on the basis of their professional experience and dignity. No Trustee shall be entitled to take loan from the Trust or to take any advantage for himself or any member of his family in whatever form or manner from the Trust.

- (g) A Trustee who by his conduct as a Trustee or in his personal life adversely reflects on the reputation of the Trust may be asked by the Board of Trustees by a resolution passed by a majority to submit his/her resignation, failing which he/she shall cease to be a Trustee with effect from the date of passing of such resolution.
- (h) The Trustees may institute, conduct, defend, compound, or abandon any legal procedure by or against the Trust or Trustees and allow time and indulgence for payment or satisfaction of any debt due or for any claims or demands by or against the Trust.
- (i) The Trustees of the Trust may obtain payments of money from all courts and Departments of the State & Central Governments including local authority or authorities.
- (j) The Trustees may purchase, construct, alter, lease, and rent partly or fully immovable or movable property from time to time. They shall have power to sell movable or immovable property of the Trust by two third of the majority in the best interest of the Trust as and when necessary and to use these proceeds for the objects of the Trust only.
- (k) The Trustees may authorize any of the Trustees to appear before the registrar or any other officials appointed for registration of deeds, documents and other instruments and to execute, present, admit and

register or cause to be registered any deed, documents etc. in which the Trust is interested or involved.

- (l) The Trustees shall be empowered to employ whole time or full time or part time lecturers, professors, faculty members, servants, clerks, doctors, nurses, technicians and other professionals and personnel according to the requirement of various institutions that may from time to time be run or established by the Trust on such terms and conditions as the Trust may decide from time to time. The Trustees shall have power to accept honorary services of any person volunteering to do the work in the Trust or in the charitable institution run by the Trust. The Trustees shall have full disciplinary control and powers over such staff, employees, and workers honorary or otherwise.

- (m) The Trust Board can form different committees to help in fulfilling the objects of the Trust. Such committees shall discharge different functions assigned to them with same rights and duties as other members of the Trust Board, except voting rights in the Board Meetings. Presently one committee is formed to look after the day-to-day affairs of the Institutions/Schools run by the trust which is named as "**Academic Development Committee**" and the members of this committee

shall be constituted by Chairman-cum-Managing trustee who will have every power to work, manage, develop, run the Institutions/Schools and other person cannot interfere in any of the matter related to the Institution/Schools.

7. **POWER AND FUNCTIONS OF BOARD OF TRUSTEES:**

- a. That, every power authority or discretion here in after conferred upon the board of trustees shall be exercised and signified by a resolution of a majority of the trustees who shall be present and vote at the meeting of the trustees provided that notice of intention to hold such meeting and the business to be transacted shall have been given to all the trustees.
- b. The management and affairs of the Trust shall vest in the Chairman- cum-Managing Trustee who will represent the Trust or its Institutions before all courts and authorities and exercise such powers as is necessary for conducting the affairs of the Trust, or its Institutions, with powers to nominate and whose decision in all matters shall be final.
- c. To decide all issues related to the administration of the trust hereof, and including all issues relating to interpretation of these presents, the administration of any institution maintained by the trust or concerning anything of any matter, relating to or connected with or arising out of these presents or operation thereof, without prejudicing to the objects of the trust, that decision of the board of

trustees on all, or any of the matters, aforesaid, shall be final.

- d. To delegate by power of attorney or otherwise by way of a resolution, duly passed by the majority of trustees present to any trustee or trustees, or any other person or persons, powers and authorities implied by law or conferred by statute or vested in the trustees by these presents. The board of trustee shall, however, not be held responsible or liable for the acts or defaults of any such person or persons, but only their own respective acts and defaults.
- e. To frames such rules and regulations for the management and administration of institutions or subsidiaries set up by the trust as they think fit and to alter or vary the same from time to time and make new rules and regulations provided that such rules and regulations shall in no case be inconsistent with the terms of these presents.
- f. The Board of Trustees shall be solely authorized to purchase, sell, construct or hire, or take on lease or dispose off any immovable property for all or any of the purpose of this trust at such price or cost or rent, and on such terms and conditions and for such period and with or without options for renewals as it deems fit.
- g. The trustees shall have power to raise or borrow for the purpose of trust from time to time in the name of the trust, or otherwise, on behalf of the trust. Such sums of money as they may, from time to time, deem expedient either on the mortgage/ hypothecate / pledge of the

whole, or any part of the property of the trust and bonds debenture deposits receipt, promissory notes with or without security guarantees, or in such other manner as they may consider proper.

- h. The Board of Trustees will follow the instructions given by any donor who makes substantial contributions towards furtherance of the objects of the trust so long as such instructions are not detrimental to the attainment of the objects of the trust and are in conformity with the provisions of the Income Tax Act 1961, or other relevant statutes.
- i. To open one or more bank accounts and to operate the same, or provide for operation of the said accounts by the managing trustee, or such other signatory / signatories on joint operation basis as the board of trustees may decide.
- j. For the management and administration of the trust, the trustees may elect one amongst themselves for each of the offices. Vice chairman, General Secretary and treasurer, the trustees may create such other office bearer positions in future, as may be deemed necessary. The term of the office bearers shall be for three years. The office bearers shall be eligible for re-election at the end of the tenure.
- k. The trustees shall have all powers specifically conferred to do things, as may be required for the proper conduct and management of the trust and in the interest of the trust, whenever such powers are not specifically conferred.
- l. The Chairman cum Managing Trustee shall be authorized and empowered to represent the board of trustee in all

forums and activities and also, he will execute and implement all the decisions of the board of trustee.

#### 8. MEETINGS

1. The Trustees may meet together as and when they may think necessary. But they shall hold at least four meetings in a year.
2. The quorum at a meeting of the Trustees shall be of two, when the strength of the Trustees is four or less. The quorum shall be three if the strength is more than four.
